Message from Executive Director

Within our own organisations...

We cannot be fully accountable to the people we work with, without critically considering how we address racism and racial discrimination within our own organisations and in the humanitarian sector.

Over the past several months, the Black Lives Matter movement is reverberating through the aid sector. As member of the Inter-Agency Standing Committee (IASC), ICVA has <u>reaffirmed</u> the pledges to zero tolerance to racism and racial discrimination and committed to eliminating such behaviour. ICVA takes forward further actions to address racism and racial discrimination at the workplace, in <u>partnerships</u> and also through the work of the members on the ground.

The future that we are embedding in our <u>ICVA 2030</u> should value our <u>diversity</u> through active inclusion at all levels: in our membership, in our workplaces, and by fostering more inclusive and diverse ways of working.

We cannot either be fully accountable without critically considering... how we are <u>tackling</u> <u>sexual exploitation, abuse and harassment</u> (SEAH). The <u>collective NGO statement</u> at the UNHCR 79th meeting of the Standing Committee recalls efforts to prevent and respond to SEAH. You will also read in this Bulletin on the "Interagency Community Outreach and Communications Fund on Protection from Sexual Exploitation and Abuse (PSEA)", led by UNHCR and ICVA.

People affected by crisis put a huge amount of trust in us. Being assertive at all times in addressing SEAH at all levels is critical. The <u>latest allegations</u> from the Democratic Republic of Congo that hit the media attention last week is just another reminder that ongoing work should continue. In no case should we be diverted by the responsibility and the related power and trust issues that go along with tackling SEAH.

SEAH inflicts harm on the people we are obligated to protect. It jeopardises the trust and credibility of our assistance work. With the twin health and economic crisis, humanitarian NGOs are under further pressure to remain and deliver principled and effective humanitarian assistance.

NGOs are also under pressure to step up to be key actors in delivering on expectations and build a more resilient system for the future. A system with valuable innovations and improvements in how we work, live, and treat each other.

To reach all of this, it requires us to continuously challenge and improve ourselves in how principled we are within our own organisations and in the humanitarian sector, taking all the necessary actions to ensure we remain faithful to the trust people put in us.

5. ICVA membership sessions: A collaborative future for principled and effective humanitarian action

Throughout the past months over 80% of our members have contributed to the <u>ICVA</u> 2030 strategy process. **We thank you all for your inputs** whether through the survey, interviews, regional member meetings and at the September membership sessions.

In August there were two regional meetings with members. On 12 August a **MENA Members and Partners meeting** which also included a session on financing priorities and trends. The meeting report is <u>available here</u>. And on 26 August **members from the Africa region** explored synergies and how ICVA members could increase the presence of the network.

On 2 and 3 **September two online sessions** were held for ICVA members, replacing the ICVA membership day initially scheduled as a one-day event in March. These virtual sessions took place in a very different world from the one we were in in March.

During the two September membership sessions members considered the disruptors of climate change, inequality, shifting powers and technology. We know about the dynamics of current crises, and that the pandemic is rolling into a hunger pandemic and is increasing protection needs. There were rich discussions in breakout sessions around the strategic considerations of environmental change, private sector engagement and technology and humanitarian innovation. And also, on collaborative advantage, regional development, membership engagement and resourcing ICVA.

The draft strategy will be available by the end of this year for members to review before adopting it at the General Assembly in May 2021.

Forced migration

6. World Bank-UNHCR Joint Data Center on Forced Displacement

On 27 August, one year after the launch of the Center, ICVA and some of its members attended the second meeting of the Strategic Advisory Council of the World Bank-UNHCR Joint Data Center (JDC) on Forced Displacement. The meeting was an opportunity to hear an update on the Center's work programme; discuss the JDC Strategy for the next three years; and hear about partnership opportunities, and next steps. 7. UNHCR 79th Standing Committee

Thanks to NGO contributions, ICVA coordinated the drafting and delivery of two NGO statements during the 79th meeting of the Standing Committee (16-17 September). The statements were focused on Efforts to prevent and respond to sexual exploitation and abuse and sexual harassment, and on the Update on the Grand Bargain. 8. Informal briefing on the Global Refugee Forum follow-up and the Global Compact on Refugees

On 28 September, UNHCR organised the third informal briefing of the year on the follow-up to the Global Refugee Forum with a specific focus on the initiatives linked to the Global Compact on Refugees. On this occasion, ICVA delivered an NGO statement highlighting key messages, particularly on COVID-19, multi-stakeholder engagements, the three Support Platforms, and the Asylum Capacity Support Group. 9. UNHCR-NGOs Annual Consultations: 29-30 September

ICVA and UNHCR co-organised this year the <u>virtual Annual Consultations</u> that brought together participants from over 110 organisations. This year, NGOs, Refugee-Led Organisations, and UNHCR exchanged on the theme: "Responding to pandemics", around Resilience and Inclusion; Protection Considerations; and Climate Action. As part of the Consultations, there was also a side event on "Partnership Agreements during Pandemics" which took place on 28 September. The key outcomes of the Consultations including various recommendations are to be presented during the UNHCR's Executive Committee. The recommendations will also feed into the <u>2020 High Commissioner's</u> <u>Dialogue on Protection Challenges</u>. 10. Nansen Award winners

ICVA congratulates Mayerlín Vergara Pérez who won the 2020 UNHCR Nansen Award. Working for the NGO Renacer Fundationa, Mayerlín is a devoted Colombian human rights activist and campaigner who has been helping to identify and protect children from sexual violence and trafficking for twenty years. 11. Migrants in vulnerable situations:

The fires on the Greek island of Lesbos on 8 September renewed an urgency to address asylum access in Europe.

- The Civil Society Action Committee released a <u>statement</u> calling on the Greek government and the European Union (EU) to provide immediate humanitarian and human rights support to the Moria camp tragedy.
- In September, the European Commission launched a new Pact on Migration and Asylum. It consists of a communication and nine proposed instruments. You can <u>read more here.</u> ICVA is reaching out to members to compile and share any relevant analysis they might have of the Pact from an NGO Perspective.
- On 22 September, Oxfam International and WeMoveEurope filed a complaint, submitted by international law firm De Brauw Blackstone Westbroek, to the European Commission to trigger an infringement procedure against Greece for its systematic breached of EU law in its treatment of people seeking asylum. <u>Click here</u> to read the legal complain

GCM Objectives Review Series

<u>Migrant Forum in Asia (MFA)</u>, the <u>Cross Regional Center for Refugees and Migrants</u> (<u>CCRM</u>) with the <u>Global Research Forum on Diaspora and Transnationalism (GRFDT</u>) and the Civil Society Action Committee are jointly organising a series of 23 weekly review discussions focusing on progress at the global level of each of the 23 objectives of the Global Compact for Migration (GCM). The discussions will provide multi-stakeholder space to review progress made on the implementation of each GCM objective. The sessions started at the beginning of September and take place every Tuesday until February 16, 2021, via Zoom. More information can be found <u>here</u>.

Save the date: COVID-19 and the Global Refugee and Migration Compacts. What learning and way forward?

Between June and September, the Danish Refugee Council and the Mixed Migration Centre (MMC) have conducted two studies, looking at COVID-19 and the Global Compact on Refugees (GCR) and the Global Compact for Safe, Orderly and Regular Migration (GCM) respectively. The findings will be presented at a **joint MMC DRC webinar on 14 October 2020.** <u>Registration</u> is open until 13 October 17:00 CEST.

Situations questionnaire

ICVA contributed to the development of a questionnaire on existing practices on "Admission and Stay" and their use. This was a deliverable of the UN Migration Network Working Group 3 work plan. This working group was established with the goal of facilitating new avenues and access to legal admission and stay on the grounds of compassionate, humanitarian, and human rights protection purposes. Thereby reducing the risks and vulnerabilities migrants face at different stages of the migratory path, including in mixed movement situations. The questionnaire seeks to further that goal by identifying and mapping existing promising practice in these areas, as well as solicit information on the extent to which migrants have been able to make use of such practices.

Financing

12. IASC Humanitarian Finance Results Group (RG5): RG5 reconvened on 22 September after a summer break in August. Co-chairs OCHA and ICVA updated the group on the future of the IASC Results Group structure following the RG Co-chairs meeting that took place the week before, including on the future priorities for RG5. The IASC RGs will now continue their work at least through the end of 2021, with a review of the structure to take place mid-year. For RG5, the current priority focus areas for the group will be continued and refined for 2021, to include: nexus funding issues, quality funding (multi-year, flexible), and harmonisation and simplification of systems. These priorities have been communicated to OPAG with positive feedback, and RG5 will work over the coming weeks to identify supporting deliverables for 2021. Localization will also be a focus for RG5 in the final quarter of 2020, with the objective of increasing national NGO participation in the group and establishing a plan for engaging with local and national partners when implementing deliverables.

13. Funding flexibility and COVID-19: One of the primary finance areas of focus for ICVA, and for RG5, under the umbrella of the COVID-19 GHRP implementation has been to introduce funding flexibility measures to reduce the administrative burden of partnership agreements. This work resulted in an advocacy message to donors followed by agreement on flexibility measures among IASC members in June. For the last quarter of 2020, ICVA will continue to support funding flexibility efforts through:

- Dialogue with IASC membership to assess the current flexibility measures and which should transition to standard practice.
- IASC RG5 engagement with the Good Humanitarian Donor group to advocate for donor adoption of IASC flexibility measures.
- Engagement with NGO colleagues to improve the collection of quantitative data on flexible funding and how it flows from donor to field use.

14. The future of the Grand Bargain: Based on the current dialogue on the future of the Grand Bargain that grew out of the June 2020 Annual Meeting, ICVA, SCHR, InterAction, and Voice have released a joint statement from the NGO networks available <u>here</u>. ICVA will continue to engage with Grand Bargain signatories over the coming months to identify a clear path forward for the Grand Bargain. Priorities for ICVA include: preservation of the unique platform made up of donors, UN agencies, and NGOs; further refinement and prioritisation of key commitments; support for key root issues such as risk sharing; and further dialogue on how the Grand Bargain can adjust to maintain relevance as appropriate.

15. OCHA Regional Pooled Funds: One of the proposals developed as part of the effort to unlock NGO access to funding under the COVID-19 GHRP is to establish a regional-based pooled fund that is modelled after the current Country Based Pooled Fund approach. OCHA has initially proposed that a regional pooled fund be tested in the Sahel region and is currently working with donors to assess the potential for funding an initial rollout in 2021. This approach is distinct from the recently-piloted CERF IOM-NGO allocation, and would open access to OCHA pooled funds for NGO partners (international and local) in country locations without an established fund. As more details become available, they will be shared out through the ICVA Humanitarian Finance Working Group mailing list.

Coordination

16. COVID-19 GHRP Update

<u>Global Humanitarian Response Plan COVID-19 Progress Report: Second Edition, 31 August</u> <u>2020</u> This Progress Report summarises the collective response to the humanitarian impacts of COVID-19 in the 63 countries covered by the GHRP. It presents an update on the operational context; examples of how humanitarian partners continue to adapt their field responses; in focus sections on Protection and Food Security; a funding overview and analysis; information on how pooled funds are supporting the response; and an update on the strategic response priorities and progress against key indicators.

17. Inter-AgencyStanding Committee(IASC) IASC Emergency Directors Group (EDG):

The EDG met to discuss the situation in Lebanon, Central Sahel, and to conduct a stocktake session including consideration of the forward-looking agenda and where support from the EDG would be best placed in coming months.

The IASC Principals:

The IASC Principals ad hoc meetings on COVID-19 Response are now monthly. The September meeting with the action points covered a) the GHO/HPC 2021 process, especially around the Joint Analysis Framework; b) the Protection of IDPs issue during the launch of the 2021 GHO; c) Support to the COVAX initiative through (i) advocacy and (ii) efforts to support country readiness for COVID vaccines and sustaining immunisation services and d) concrete proposals on improving humanitarian access and addressing bureaucratic and administrative impediments faced by NGOs.

ICVA Principal co-signed the statement by IASC Principals on Racism and Racial

Discrimination. This statement highlights the importance of examining and addressing racism and racial discrimination within our own organisations and in the humanitarian sector, including by expanding diversity at all levels in our workplaces, and fostering more inclusive and diverse ways of working.

Operational Policy and Advocacy Group (OPAG)

In September, the OPAG met twice. In the first meeting on 12 September, the focus of the discussion was on localization and duty of care issues in light of COVID-19. The Somalia NGO Consortia and UNHCR co-chaired the sub-group on localisation and shared the group's agreed priorities. There was also a presentation by ICVA and WFP on progress of the duty of care task team, which first draft of minimum standards will be shared with the OPAG by mid-October.

The second OPAG meeting discussed the priorities of the Results Groups in light of the extension of their mandate till end of 2021. Recognising the value of the results produced, especially in the recent months during the COVID-19 response, OPAG considered how to streamline work and strengthen collaboration among the Results Groups and rationalise structures; enhance the working methods, including in terms of the interaction between the Results Groups and the OPAG; how to better support the field and translate policies into practices as well as the collaboration between the OPAG and the IASC's Emergency Directors Group (EDG).

18. Update on IASCResults groups:

RG 1 Operational response:

The Results Group met to consider next steps and revise its work-plan including recommending the simplification of deliverables. It was proposed that 3 (out of

6) subgroups – those on Humanitarian Leadership, Data Privacy and Emergency Preparedness – would be separated from the RG1, although their work would continue to be supported and delivered in an interagency fashion. The subgroup on Bureaucratic and Administrative Impediments (BAI) shared the draft of its initial country-level study which focused on Myanmar with RG1 members for comment.

RG2 Accountability and inclusion: No updates

RG 3 Collective advocacy:

The Results Group met to consider its ongoing work-plan and to focus on improving collaboration with other Results Groups and the EDG.

RG 3 Sub-group on climate change:

The Subgroup on Climate Change met online on 24 September 2020 to discuss upcoming events; the status of climate change Key Messages and the Advocacy Strategy; and potential joint initiatives.

RG 4 Nexus:

The joint INCAF-IASC RG4 session on the Peace Pillar in the HDP Nexus took place on 24 September. The meeting unpacked what "Peace" means in the context of the Humanitarian-Development-Peace Nexus (HDPN). A panel of five experts explored a number of dilemmas related to the Peace component of the triple nexus trying to dispel misunderstandings and bring clarity.

The NGO forum in Mali presented their view on the challenges and potential opportunities for humanitarian assistance and protection in Mali taking into consideration the enduring political complexity.

The IASC RG 4 Community of Practice on the Nexus co-facilitated by WFP and ICVA, 17 September meeting focused on Cameroon and the current aspects of the Nexus rollout tht is happening in the country.

RG 5 Humanitarian Finance: See update above under 'Financing.'

19. NGO Fora Support:

The activities of the NGO Fora from the different regions have been gaining momentum through the ICVA Boost Project. Some of the latest activities are as follows:

- Hosting of the National Workshop on Localization Dialogue by the Tanzanian Refugee and Migration Network (TAREMINET) on 8 September 2020, in Dar es Salaam, Tanzania. The objective of the workshop was to sensitise local humanitarian actors and members of TAREMINET to come to a common understanding on "Localization" in the Tanzanian context. - Results are being compiled from an assessment from PNGO on the "Assessment of the Local NGOs Participation in the Cluster and The Humanitarian Programme Cycle"; and capacity building sessions are on-going through the support of the NGO Fora Boost fund.
- Increased visibility and coordination capacity of the supported NGO Fora within the humanitarian space; and emerging platforms for cooperation among the different Fora – CHOI/CHINGO in Cameroon.

22. Safeguarding:

PSEA Outreach and Communication Fund

In February 2020, UNHCR partnered with ICVA to launch the PSEA Community Outreach and Communication Fund in order to support the critical work that NGOs do every day to ensure that people we serve are fully aware that humanitarian assistance is never conditional on any transaction or exchange of any kind, to prevent situations of sexual exploitation and abuse and to raise awareness to reporting mechanisms. The Fund has received over 1600 applications and we are pleased to announce that 19 NGOs from 19 countries have been selected and that the grants were all transferred for them to start implementing their projects, to be concluded by the end of 2020. Region Specific

ICVA regional teams have been working intensively with inter agency coordination groups to ensure national and international NGO involvement and active contribution to the ongoing preparedness and response to the COVID19, including to liaise at the country, regional and global level.

24. Asia and the Pacific

ADB-NGO Consultation: Asia and Pacific: Fragile and Conflict-Affected Situations On 25 September, the Asian Development Bank (ADB) organised a virtual NGO consultation meeting with support of ICVA, for the development of its new approach to working in conflict-affected countries like Afghanistan and Myanmar and the small island nations like Marshall Islands, Kiribati and Tuvalu. The causes of fragility in the region are quite unique - considering this, we are seeking civil society stakeholders who would like to participate in consultations on how we can develop specific approaches for each context. We will host two sets of consultations: As the first round of a two-round consultation process, the consultation was attended by ICVA member NGOs, NGO networks particularly working in fragile and conflict-affected situations to help ADB identify the scope of the approach. The second round will be to respond and provide input into the draft approach paper later. If you are interested in participating, contact:



ICVA-ADRRN-HFI-HI NGO learning series: "Humanitarian Work in the New Normal Age"

Human Initiative (HI) and Humanitarian Forum Indonesia (HFI), with support from Asian Disaster Reduction and Responds Network (ADRRN) and ICVA, are producing a webinar series (5 webinars) between July and the end of 2020 which aims to create a platform for CSOs and CSO networks in Asia and the Pacific to have open discussions on critical themes focused on how CSOs are adapting themselves to address the needs in a COVID-19 era. On August 26, the 2nd learning webinar focused on "CSO's Role and its Sustainability in the New Normal Age" in Asia and the Pacific; and on September 23, the 3rd webinar focused on the theme "Children as a Vulnerable Group in the Middle of Conflict."

The next Webinar will be held on **28 October 2020** with the topic: **Maintaining Accountability in the Humanitarian Response during Pandemic**.

Challenges and opportunities for the protection of Rohingya maritime movements On 25 September, ICVA Asia was directly engaged in a briefing on "Rohingya maritime movements across the Andaman Sea: Challenges and opportunities for protection". An update on Rohingya refugee maritime movements in 2020 was shared, and a number of regional advocacy efforts and approaches on protection at sea were also discussed.

25. Africa Region:

COVID-19: Through August and September there was a scattered increase in detected COVID-19 cases in Africa, yet the protracted situation caused several countries to review their restrictions. There is a general improvement of access to communities in need of humanitarian action, however there are still critical situations. NGOs in DRC for instance advocated for increase access to remote regions and expanded inclusion of National NGOs in the planning and delivery. Overall, NGO actions have been supported and their voices relayed at several levels with particular focus on Cameroon, DRC, Somalia and Mali.

IAWG: ICVA contributes to the work of the <u>Inter Agency Working Group Africa</u> – <u>IAWG</u>, in its recently established COVID-19 working group. ICVA's main role is to connect the work of the working group to the global level and ensure bi-directional exchanges.

Sahel: A particular focus is confirmed on Sahel with NGOs preparing to contribute to the Senior official meeting (SOM) and ministerial meeting on Sahel planned for October 2020. ICVA has also successfully pushed for the presence of NGO Fora at the OECD INCAF.

State of the World's Forcibly Displaced Report: Along side the UNHCR Regional Office in Nairobi, and the Institute for Security Studies (ISS) office in Addis Ababa, ICVA contributed to the background paper on the State of the World's Forcibly Displaced Report to be published next year. The aim was to provide an overview of the most important developments in the Horn, East and Great Lakes region in policy and practice over the last decade.

ICVA held various meetings and connected its members with the **IGAD Secretariat** regarding the "Kampala declarations on Jobs, Livelihoods and Self Reliance for Refugees, Returnees, and Host Communities in the IGAD region".
