## Message from Executive Director

## A Call for More Investment in Anticipatory Action

Today, Pakistan's historic floods have inundated a third of the country, affecting 33 million people. Across the Horn of Africa, 20.5 million people are facing a dire and entirely avoidable hunger crisis as the region faces one of the worst droughts in recent decades.

One year ago, almost to the day, NGOs, governments, aid agencies, international financial institutions, and private-sector companies made <u>new pledges of anticipatory financing and programming</u> worth tens of million and committed to acting early to mitigate the effects of crises.

Anticipatory action has increasingly moved from being niche and technical to the recognition that it should become mainstream and without delay. If we manage to take steps to protect people before a disaster strikes based on early warning or forecasts, we would be reducing the humanitarian needs.

The latest <u>State of the Humanitarian System</u> study launched 7 September reports that "the rise of anticipatory and early action is also one of the most significant shifts observed in the system."

Anticipatory action has moved higher on the agenda of the humanitarian response sector. It is well documented that early warning forecasts and projections have improved and are increasingly credible. However, despite the capacity of the system, predictions are at times downplayed or ignored and triggering anticipatory action is fraught with difficulties.

With the effects of climate change becoming more and more destructive, acting early is transformative for our sector as the humanitarian financing gap keeps growing.

The momentum to embrace an anticipatory action approach in aid response goes with the challenges that stand in the way. The NGO community monitors the <u>2021 anticipatory action pledges</u> that signaled a new urgency in the push for anticipatory action, the practice of providing financing and aid activities based on risk triggers to mitigate the effects of a disaster before it hits.

Today, disasters are hitting in devastating manners. If the world is confronted to discussing famine declarations or confronted with insufficient preparedness and cutting risks due to massive floods, we have then failed in sharing responsibility in shrinking the needs.

We have various tools that help us anticipate and prepare to mitigate the risk. Let's use them efficiently, while also investing further in anticipatory action.

## 5. The Geneva Humanitarian Hub

A new Geneva Humanitarian Hub was launched on 1 July 2022.

This exciting initiative has been driven by a desire for even greater collaboration between organizations to address the increasing and complex humanitarian challenges we are trying to address. This new co-working space will strengthen interactions and create synergies between the humanitarian actors based in Geneva to increase our impact, whilst reducing our operational costs.

The vision is a space where a community of humanitarian actors foster collaboration and innovation. The initial organizations who have come together in this collaborative venture are the Norwegian Refugee Council, the Danish Refugee Council (and its partners Joint IDP Profiling Service, Mixed Migration Centre, H2H Network), the Core Humanitarian Standard (CHS) Alliance, the International Council of Voluntary Agencies (ICVA), Save the Children, the Internal Displacement Monitoring Centre (IDMC) and Oxfam International.

## 7. Global Compact on Refugees (GRF)

Fulfilling its role as member of the NGO Reference Group for the 2023 Global Refugee Forum (GRF), ICVA has been disseminating information and collecting suggestions and feedback from its membership about the process leading to the second GRF. This includes encouraging NGOs to provide comments and inputs on the 2023 GRF Proposed Concept Note through a dedicated ongoing UNHCR survey and a related online form designed to collect expressions of interest in areas where stakeholders would like to engage in mobilizing support and pledges in preparation for the next GRF. In August, UNHCR also released the final version of the Third Country Solutions for Refugees: Roadmap 2030, the successor process to the Compact's Three-Year Strategy on Resettlement and Complementary Pathways (2019-2021). This Roadmap was developed through a multistakeholder process, including ICVA and some of its members. French, Spanish, and Arabic versions of the Roadmap document will also be made available.

## 8. Solutions to Internal Displacement

As part of their engagement in the follow-up to the High-Level Panel on Internal Displacement, on 14 July, ICVA and InterAction organized an exchange between their members and the recently appointed Special Adviser on Solutions to Internal Displacement, Mr. Robert Piper. This first meeting aimed to exchange on the Special Adviser's role and priorities. Building on <u>earlier feedback</u>, NGOs emphasized specific areas of work to ensure the implementation of <u>the UN Secretary-General Action Agenda</u> notably through governments' ownership and leadership on internal displacement solutions. Key takeaways notes have been circulated to members. InterAction and ICVA will continue to facilitate cooperation and synergies.

## UN Special Rapporteur in the field of Cultural Rights visit to Germany

Alexandra Xanthaki, the Special Rapporteur in the field of cultural rights, is currently planning her upcoming visit to Germany, which will take place between 12 and 22 September 2022. In this context, she is presently gathering information to get a better understanding of the issues at stake in the field of cultural rights, the persons (specialists, academics, artists, decision makers) and organisations (civil society, institutions facilitating participation in cultural life, local organisations) to meet and the place to eventually consider visiting. The Special Rapporteur has identified three preliminary themes for the visit. They include cultural rights of migrants, memorialization and expression of diversity including that which relates to LGBT+ or gender diverse populations. She is open to suggestions on other areas you believe should be considered as well.

## 10. Humanitarian Finance Initiatives and the Grand Bargain 2.0 Briefing

The briefing will be done by Jeremy Rempel, ICVA's Head of Humanitarian Finance, on 13 September, with NGO Secretariat and members of the NGO fora in Ethiopia, Somalia, South Sudan and Sudan. This meeting will be a follow up of the last year briefing, with an opportunity to hear highlights on global updates and progress on Humanitarian Finance initiatives and the Grand Bargain 2.0. There will be an opportunity to share experiences, challenges and initiatives, with peers in the region.

## 11. Inter-Agency Standing Committee (IASC)

## System-Wide Scale Up Activation for the Humanitarian Response in Somalia

A team of senior UN and NGO (ICVA and World Vision International) representatives from the IASC Emergency Directors Group (EDG) visited Somalia from 24 to 28 July 2022 to identify gaps, challenges and immediate priorities for operational and strategic support relating to the ongoing drought response. Mission objectives also included increasing awareness around the situation and mobilizing additional resources and capacities to enable the further scaling up of the response, with a particular focus on sub-national level. The team engaged with affected people, frontline humanitarian workers and local officials in Baardheere in Jubaland State and Baidoa in South West State, as well as with UN and NGO leadership and humanitarian donors in Mogadishu.

Following the mission, the EDG recommended to the IASC Principals to activate a System-Wide Scale Up for the response. The recommendation was based on the current scale of the needs, the anticipated continuation of the drought into 2023, the complexity of the operational challenges and the importance of an integrated response at scale to meet urgent and increasing needs. The IASC Principals met on 11 August and agreed to declare the Scale-Up Activation immediately.

On 29 July, ICVA conducted a debrief on the EDG mission for NGOs in Somalia and at regional and global levels. On 25 August, members of the EDG mission team conducted a follow-up briefing with humanitarian donor representatives from capital level.

## **IASC Principals**

IASC Principals in their ad hoc meeting on Somalia on 11 August, took additional follow-up actions of declaring the system-wide emergency activation procedures (IASC Scale-Up) in Somalia effective immediately. Follow-up actions to strengthen efforts, capacities and resources to address Protection, Gender-Based Violence, and Sexual Exploitation and Abuse in the initial phase of the response and report back on progress in these areas as well as focus on reinforcing sub-national capacity and delivery, including by getting funds fast and at scale to front line responders.

IASC Principals will reconvene the week of 12 September to discuss progress in Somalia and Horn of Africa.

# Statement by Principals of the Inter-Agency Standing Committee on Famine in Somalia

ICVA IASC principals signed an IASC <u>statement</u> urging all actors to facilitate immediate and safe access for humanitarian operations. The principals also appeal to donors to provide immediate, flexible funding to enable humanitarian agencies on the ground to rapidly scale up and prevent more deaths, protect livelihoods and avert a deepening catastrophe.



## 12. Humanitarian Access and Advocacy

The IASC Taskforce 3 on Preserving Humanitarian Access and Space meeting for August was postponed until September. The Bureaucratic and Administrative subgroup met to discuss the dissemination, socialization and monitoring of the <u>IASC Framework</u> on Understanding and Addressing Bureaucratic and Administrative impediments.

ICVA held its inaugural meeting of the Humanitarian Access Working Group in August to discuss ICVA's approach to influencing humanitarian access and space. The Working Group provides ICVA members with a dedicated NGO space to discuss and feed into the policy work of the IASC Taskforce 3 and share best practices and research in addressing humanitarian access impediments.

## 13. Vaccine Delivery Report

The worldwide increase in COVID-19 cases has continued throughout July, with <u>reports</u> showing that only 59 out of 194 WHO member states have vaccinated more than 70% of their population. Although there has been some progress, eleven countries including eight with humanitarian response plans remain below 10% vaccination coverage, leaving crisis affected populations vulnerable to this disease.

The COVID-19 Vaccine Delivery Partnership is seeking technical support from NGOs to develop One Plans and One Budgets in a range of contexts.

## 16. Be Globally Distributed and Locally Rooted

ICVA Women's Humanitarian Leadership Training Programmes for Local and National Women-Led NGOs (WLO) and Local CSOs in MENA, Asia and Africa Regions

ICVA Women's Humanitarian Leadership Training programmes for local and national WLO and local CSOs in the selected regions will commence in October – November 2022 in MENA region followed by other patch of training in Asia and Africa regions. The training will focus on strengthening leadership, collective advocacy, donor and partner engagement and policy influence, and other related subjects tailored to the participants needs and expectations.

Three training programmes will be organized per targeted region serving as a regional platform to have a discussion on concrete thematic subjects, inviting different stakeholders and decision makers to attend and participate in the discussion. This training and learning programme will serve as an opportunity of mutual learning and exchange, the participants from WLO in each region will be given the space to present their stories, progress, and exchange on how they have been able to address certain challenges in their own country context to their peers at the regional workshop.

## Localization Baselining Initiative in Yemen

The local CSO Network in Yemen that is led by ICVA local members in the region are currently reviewing the first draft of the localization baselining report by the local CSO actors. The main objective of the localization baselining is to collate inputs for advocacy with different partners to highlight specific areas where support is needed to move localization forward and enable tracking progress against localization commitments at local and national levels.

#### Changes in ICVA Representation in Africa

# Somalia NGO Consortium (SNC)- Announcing a New Webinar Series on Climate Adaptive Responses

On 5 July, SNC hosted an event on "What does climate change look like in Somalia, and what actions can be taken during the drought". The aim was to present the findings of a recent assessment on climate change outcomes for Somalia and to discuss how and why this is important for aid actors responding to the current crisis. From this first event, it emerged that there is a wide range of existing climate change-related projects and opportunities for making current and future programming more 'climate change sensitive and adaptive'. These opportunities cut across stabilization, humanitarian, and development programming. However, there is little knowledge and learning being shared across the 'Nexus' and SNC members expressed interest to learn more about how and when to use climate adaptive approaches. Based on these findings, SNC in collaboration with Building Resilient Communities in Somalia and Centre for Humanitarian Change are offering a series of online weekly webinars around the theme of climate adaptive programming. The research also sheds light on good practices and good examples that various actors can use to develop guiding tools and strategic thinking around inclusion of NEXUS approaches in their strategies and programs. # Regional Capacity Development and Knowledge Sharing Event on the Humanitarian Development and Peace Nexus (HDPN)

This event was organized by a Regional Issue-Based-Coalition on the Humanitarian Development and Peace Nexus (IBC HDPN) in Arab Region in collaboration with the Global Nexus Academy on 18 – 21 July. It brought together actors from across the three pillars to advance a common understanding of nexus approaches and deep dive into what the overarching issues to collectively act upon to bring crisis-affected countries back on track to achieve sustainable development and peace. ICVA Deputy Regional Representative moderated the kick-off panel discussion on how to make the NEXUS work with different stakeholders.

#### NGO Fora Support Program – NGO Fora Capacity Fund

ICVA's NGO Fora Capacity Fund aims at supporting NGO fora effectiveness, their commitment to service delivery and the quality of their coordination platform for information exchange. The 2022- 2023 grants aim at specifically supporting NGO fora initiatives aimed at addressing issues related to humanitarian principles and access through improved coordination.
