THE FUTURE OF THE GRAND BARGAIN

FINDINGS OF THE SURVEY OCTOBER 2022

The survey was the first step in the process to collectively determine the future of the Grand Bargain after June 2023. The purpose of the survey was to measure the interest of the Signatories for their continued engagement and resources invested in the process. This exercise also provided quantitative data on the key elements of the Grand Bargain's structure that bring the most added value in achieving efficiency and effectiveness of humanitarian aid.

RESPONSES TO THE SURVEY



The survey was limited to one response per Signatory. The targeted respondents were Grand Bargain Sherpas to ensure survey findings reflected senior-level stakeholders and institutional buy-in.

POSITIONS ON THE FUTURE OF THE GRAND BARGAIN

ALL CONSTITUENCIES are in favour of continuing the process, **but with changes** to the current structure.



POSITIONS ON STRUCTURE AND THE VALUE OF EXISTING ELEMENTS

Call for a simplification of the structure.

While majority believe a structure is needed to monitor the implementation of the Grand Bargain commitments (66% of respondents)...

...78% believe that the overall structure (workstreams, caucuses, National Reference Groups), should be simplified...

...Only 42 % would like to see the governance structure simplified (current governance: Eminent Person, Facilitation Group, Secretariat)

Respondents see value in governance bodies towards driving aid efficiency and effectiveness

Less value seen in workstreams, National Reference Groups, and caucuses

It should be taken into consideration that the **National Reference Groups** have only recently started, and therefore have not had time to demonstrate their added value.

COMMITMENTS TO CONTINUE AS A SIGNATORY

92% feel there is a continued commitment

to participate in the Grand Bargain in their institution

6% are undecided

However, only 46 % of respondents said they would invest financial resources to support the implementation, while 70% donors are undecided

Only 2% feel there is NO continued commitment to participate in the Grand Bargain in their institution
