Ghida Anani is the Founder & Director of ABAAD — Resource Centre for Gender Equality, a leading CSO in the region advocating for gender equality. Ghida is putting in place the infrastructure for a sustainable system of protection against gender-based violence. She engages stakeholders that others avoid or fight: men, parliamentarians and ministries, and religious leaders. She has led a number of public opinion campaigns, notably the #Undress522 which resulted in a historical parliamentary vote, repealing Article 522 — the infamous "rape-marriage" law - from the Lebanese Penal Code. In 2019, the campaign received the first prize "UN SDG Action Award" for the most impactful campaign globally.

As an expert in GBV and Child Protection, Ghida has published a number of studies, articles, training kits and community educational materials on GBV & Child Sexual Abuse in Lebanon and the MENA region. She has also dedicated some of her time teaching at the Faculty of Public Health at the Lebanese University.

In 2018, Ghida was listed by the World Bank as one of 10 Inspiring Women Entrepreneurs Making a Difference across MENA and in 2019 she was selected by the UN Solutions Summit as one of the 10 extraordinary solution makers across the globe advancing the SDGs.

Her remarkable experience as the founder and director of ABAAD, brings a wealth of expertise to the ICVA Board, particularly in the realm of gender equality and combating gender-based violence. Her proven leadership in advocacy and policy change positions her well to contribute to the effective implementation of

decisions made by the ICVA General Assembly. Operating out of its headquarters office in Sana'a and its offices in Hodeidah, Hajjah, Abs, Raymah Taiz, and Aden, ADO, provides critical education, protection health, livelihood, and WASH services to urban and rural communities. ADO believes that a woman is the essence of life, therefore it has devoted all its activities and programs to empower and educate a woman, because the educated and empowered woman will lead to an educated family in which empowered family will ensure a developed society leading to a civil state, good governance and conscious civil society out of oppression.



Action Against Hunger is a network of 8 member organizations that have as mission to save, improve and protect lives by eliminating hunger through the prevention, detection and treatment of undernutrition, especially during and after emergency crises caused by situations of conflict, displacement, poverty, discrimination, inequality or natural disaster. Our principled humanitarian interventions in more than 58 countries, together with some longer term solutions or policy transformation, assure, in close partnership with many international, national and local actors and stakeolders, solutions to hunger and a delivery of basic services for affected communities and populations. Main sectors of work are nutrition, food security, health, agriculture and WASH. Special attention goes to women and children. With extensive experience in countries and populations affected by conflict and climate change, and a deep understanding of specific contexts and vulnerabilities.

On global and national level, we are very active on cluster level, support intensively FAO-IPC and SMART assessments worldwide with unique technical expertise, country based pooled funds, HCT, HLTF for famine prevention, WFP executive committee, VOICE board, and active membership with ICVA, Interaction and various national platforms. We are a signatory of the code of conduct for International Red Cross and Red Crescent movement and non-governmental organizations in disaster relief. Importantly, all ACF staff strictly adhere to humanitarian principled aid. ## Africa Development Aid (ADA), South Sudan Rev. John Riek Yior

## Organisation Profile

Africa Development Aid (ADA) is a Christian base, humanitarian and development non-government organizations formed legally registered by the Ministry of Justice and Relief and Rehabilitation Commission of the Government of the Republic of South Sudan in 2012, and Relief and Rehabilitation Commission 2016. ADA has a commitment to deliver humanitarian relief assistance to the most vulnerable populations and recovering from disasters. We are a Christian based organization and take the gospel to the unreached communities. Through our Christian outreach programmes, we are able to identify critical needs on the population and tailor our programmes appropriately.

We provide lifesaving interventions that include but not limited to NFIs, WASH, Community Nutrition, Food Security and Livelihood, Emergency Education, Child Protection and Peace Building. In addition, ADA has a focus on community health and nutrition services to reduce the high prevalence of communicable diseases such as malaria and diarrheal diseases as well as acute malnutrition among children less than five years including pregnant and lactating mothers. In addition, ADA will be keen to implement community based maternal and child health services.

Our primary target beneficiaries include children, women, youth and men from IDPs, returnees, refuges and mobile pastoral communities. Our secondary beneficiaries include host communities.

We work with donors such as UNICEF, CAFOD, ZOA, Christian Aid, Caritas Germany, SSHF, IOM, Caritas Swiss, CORDAID, NPA, Save the Children, Tearfund, and NCA. ADA is flexible and open to partnership with other implementing partners. ADA works closely with local community leaders and volunteers to reach populations in secure locations. It is important to note that ADA is the focal point for partners Humanitarian Coordination in Fangak Country and plays instrumental role in building better liaison with the host community and NGO actors on the ground. Working in conflict fragile environment and mindful on the need to ensure that communities live peacefully and embrace peace within their communities, ADA is planning to integrate conflict sensitivity into its programmes with the aim of enhancing Disaster Risk Reduction and mitigating conflict of interest existing in the communities and those arising from interventions that ADA plans to undertake.

ADA believes in empowering communities to be self-reliant even during emergencies. Our approach is that. As much as we respond to meet the immediate needs of the vulnerable people, we provide them with the skills and knowledge as a means to meet their needs. Staff who work with communities do comply and sign code of conduct including PSEA.

## Airlink, USA Mr. Steve Smith

## Organisation Profile

Airlink is an international humanitarian organization providing free transport and logistical solutions for a global network of 200+ NGO partners. Airlink's mission is to ensure transport costs are not a barrier to NGOs responding to disasters and other humanitarian crises. It supports NGO programs covering five key areas of humanitarian need: Rapid Onset Disasters (earthquakes, hurricanes, floods, outbreak of war, etc.), Health Systems Strengthening, Food Insecurity, WASH, Complex Crises, Displaced and Migrant Populations, and Medium and Long-term Recovery.

Airlink's partner network comprises an even split of small-medium and large NGOs, many of which are ICVA members. We provide free transport and coordinating services through a funding mix of in-kind donations from over 50 airline and logistics partners, as well as cash donations from businesses in the aviation sector, the public, government bodies such as USAID / BHA, and grants from foundations such as the Hilton Foundation and Tzu Chi Charitable Foundation. In addition to transporting humanitarian cargo and responders for its NGO network, Airlink provides regular coordination calls during disaster responses and training sessions throughout the year to help NGOs better understand the complex compliance processes for transporting humanitarian cargo.

Airlink is a long-term member of InterAction and regularly engages with regional coordination bodies including ASEAN Coordinating Centre for Humanitarian Assistance on Disaster Management (AHA Centre), Pacific Islands Association of NGOs (PIANGO), and Caribbean Disaster Emergency Management Agency (CDEMA), UN Logistics Cluster, and the Federal Emergency Management Agency (FEMA) in the US. In addition, Airlink has a working partnership with the Red Cross and Red Crescent Societies and several international transport-focused trade bodies, including the International Air Transport Association (IATA). Airlink operates a Regional Response Framework model aiming to improve responses to regional disasters and ensure the needs of each regional community are met in the most efficient and timely way by building localized NGO and airline partnerships. The Framework addresses the globe in six regions – Asia and the Pacific, Europe, Latin America and the Caribbean, the Middle East and North Africa, North America, and Sub-Saharan Africa.

In 2023, Airlink delivered aid to over 13.7 million people, aiding 122 NGOs, moving 2,237 tons of aid and 1,686 responders. We have responded to 48 individual disasters spread across 52 countries, providing transport cost savings of \$10.8 million to our NGO partners. Airlink's experience, connections, and expertise have found us increasingly establishing and running multi-modal transport aid bridges for partners, often being the only cost-effective transport solution for operating aid programs in countries experiencing complex crises; this was the case in Haiti, Sudan, Yemen, Iraq, Syria, and Afghanistan. Additionally, Airlink has developed a substantial on-the-ground partner base, enabling capacity expansion in aid missions where NGOs hoping to operate programs lacked those direct local links. This was the case in our health systems' strengthening programs in Moldova, India, and Nepal in response to COVID- 19 outbreaks and, most recently, Trigray, Israel/Gaza, and Türkiye in response to the earthquakes of 2023.

Logistics is the little-understood keystone of humanitarian response. As Airlink has grown over its 14-year history, we have filled a critical gap in the global humanitarian and disaster response ecosystem. This is evidenced by the year-on-year increase in demand for our services through an expanding NGO partner network.

I would be an asset to the ICVA board in two key areas - 1) understanding the global humanitarian landscape and the role of NGOs, and 2) experience in leading and governing a growing and global organization.

1) understanding the global humanitarian landscape and NGOs' role

I have over 20 years of experience across multiple sectors, the the past 12 years being in the global humanitarian sector. I have amassed a comprehensive understanding of global disasters for the past decade through our responsive efforts. Public speaking, media engagements, and public presentations have allowed me to promote Airlink and the NGO sector as a whole effectively.

My extensive network, cultivated through Airlink's collaboration with over 200 NGO humanitarian disaster response partners globally, keeps me constantly informed and connected. This network extends beyond NGOs to coordination bodies and many aviation and logistics companies.

I have firsthand experience in tackling challenges related to collaboration, funding from diverse sources, and creating impactful cross-sector partnerships. Our responses to crises, such as the Ukraine war, Haiti cholera outbreak, and Ebola epidemic, showcase my ability to lead multi-partner initiatives and foster cooperation between the private sector, NGOs, philanthropy, and government aid agencies.

Furthermore, Airlink's engagement across five themes of activity, namely Rapid Onset Disaster, Displaced and Migrant Populations, Health Systems Strengthening, Food and Water Insecurity, and Medium and Long-term Recovery, provides me with a nuanced understanding of on-the-ground realities across critical areas of sector activity on a global scale.

2) experience in leading and governing a growing and global organization

I have steered Airlink from its humble beginnings to becoming a pivotal partner in the NGO sector. Under my leadership, Airlink has achieved a remarkable 40-fold increase in both humanitarian impact and financial growth. My hands-on experience as the President and CEO of Airlink equips me with invaluable insights into the challenges faced by NGOs at every stage of growth.

At a macro level, I offer a distinct perspective rooted in Airlink's specialization in transport, logistics, and supply chain management in disaster response. Recognizing the critical significance of this often-overlooked aspect, I aim to shed light on its importance, considering that 73% of the cost of any aid program goes to the supply chain.

Airlink's unique position at the intersection of the private sector, NGOs, and aid agencies has afforded me practical insights into successful collaboration models and best practices in this domain.

In 2023, I was selected as a Presidential Leadership Scholar - a program run by four U.S. Presidential Libraries - George W. Bush, Bill Clinton, George H.W. Bush, and Lyndon B. Johnson - to learn from and harness the lessons learned during their administrations. I also serve on the Board of the Aero Club of Washington, DC.

## All India Disaster Mitigation Institute (AIDMI), India Mr. Mihir Bhatt

## Organisation Profile

All India Disaster Mitigation Institute (AIDMI) is an active member of ICVA for decades.

The AIDMI is one of the first local non-governmental organisation based in Gujarat, India. It is a community-based action planning, research and advocacy organisation, working towards bridging the gap between policy, practice, research, and learning related to humanitarian crisis, disaster mitigation and resilience to climate change adaptation as laid out in National Disaster Management Plan of Government of India of 2019; Sendai Framework; and Paris Agreement.

AIDMI is committed to reducing the development, humanitarian, and climate forces that lead humanitarian crises.

AIDMI's local action is always strategic. In 2023 it utilised its unique Livelihood Relief Fund for flood affected female farmers of Punjab (500) and casual labour of Gujarat (1000). The fund so far has reached out to over 30000 families.

Similarly, AIDMI has made over 5000 schools safe with UNICEF, UNDP, Save the Children, and various state authorities.

AIDMI has built hundreds of water harvesting structures, piloted micro insurance programme, offer innovative trainings of local leadership, and supported upscaling innovative learning and evaluations of hundreds of organisations in India and beyond.

Established after the 1987-89 national humanitarian droughts crisis, AIDMI has worked over the decades to cover over 18 types of humanitarian crises in nineteen states of India and beyond to nine countries in Asia. AIDMI links local communities to national and international levels of risk reduction, relief and long-term recovery and climate resilience programmes and policies. As an action-learning organization, AIDMI promotes disaster risk mitigation and adaptation to climate change by supporting, capturing, processing and disseminating disaster related information, lessons and innovative ideas.

AIDMI routinely carries out stakeholder and affected people's round tables for national policy shaping; trainings of trainers for capacity building of local leaders; reviews, evaluations, and research studies for local learning; and pilot projects where the affected citizens are in the centre.

Interconnected networking with local to global diverse organisations is AIDMI's constant goal. Examples follow.

AIDMI has worked with ICVA as its member for now over decades, including being part of its consultation on loss and damage finance at Asia and global level; representing ICVA in several UN and RC initiatives; joining and promoting climate training by ICVA; zero carbon tool review and utilisation; and other issues at the regional and global level.

AIDMI represented ICVA to COP28 UAE in over 9 panels and has developed a three year follow up programme on loss and damage funding for affected population where AIDMI will work with ICVA members, if given a chance.

AIDMI is developing its plans for COP29 with focus on finance for resilience including insurance and credit and will work with ICVA members in the coming years.

AIDMI co-lead Disaster Emergency Committee's (DEC) two landmark evaluations of (1) the Gujarat earthquake of 2001 and (2) Tsunami Evaluation Coalition of six UN, eleven INGOs, and five countries in Asia.

AIDMI has co-chaired the revision of standards process with CHS Alliance management with success and will now devote time to work out the roll-out and utilisation of the revised standards in key regions and organisations.

For the last two years AIDMI has been working with the Inter-Agency Standing Committee (IASC) on finding opportunities for mainstreaming centrality of affected population, making environment part of recovery process, and promoting localisation in all humanitarian programmes.

AIDMI has worked with ALNAP over the years to advise several State of the Humanitarian System (SOHS) reports, including the latest of 2022; taken the findings to local organisation in India, Bangladesh, and South Asia for utilisation. AIDMI also, as a follow up, designed and developed the first-ever Strengthening the Humanitarian System in India report with World Food Programme (WFP) and Sphere India and is taking the findings for accelerated utilisation by local authorities and civil society.

AIDMI has shaped research and innovative needs in the humanitarian sector for over two decades and now it is doing so in Central and South Asia with Deakin University and ELHRA. Findings of this will be of use to ICVA members in coming years for programming in the areas of dynamic coordination, leverage finance, distressed migration, and transformative networking. Similarly, AIDMI is a founding member of International Humanitarian Studies Association (IHSA) where it has contributed to informing humanitarian studies with demands from the communities in the global south.

Currently AIDMI is busy with working on Asia (India and Bangladesh) and Central Africa global project, a unique lateral learning programme on and around heatwaves with universities, authorities, and donors. AIDMI focused on data and heatwave affected population in its learning.

AIDMI runs Southasiadisasters.net publication that is locally led bottom up publication of diverse stakeholders of humanitarian sector with over 200 published issues of global regional and mostly local humanitarian, disaster risk reduction, and resilience concerns.

AIDMI links affected people with policy and aims at making policies bear fruits for affected population in all its work.

Mihir is the Director of the All India Disaster Mitigation Institute (AIDMI), one of the first local organisations active at local, national, and global levels.

He has been evaluating the humanitarian work of UN, international nongovernmental agencies, authorities, and local organisations on beneficiary feedback, rehabilitation activities, disaster risk reduction, and climate change adaptation projects in Asia and the Pacific which he will bring to ICVA members for use.

Currently, he is involved in underlying accountability in core humanitarian standards, Environment Charter, and UN task forces on accountability to affected populations as well as follow up to loss and damage funding to local civil society. All of which is of use to ICVA members.

As an ICVA member he has already contributed to ICVA Strategy 2030, regional consultations, global events and made representation at UN events such as COP28 UAE in nine panels. Thus Mihir has now decades of working relations with ICVA at global, regional, and local level.

Mihir supports Humanitarian Finance related various initiatives: climate financing and linkages to humanitarian action; local loss and damage funding; health and well-being impact of heat on Forced Migration; impacts of climate change extreme events and vulnerable communities such as women, casual labour, and tribals. Mihir will bring this policy and research experience to ICVA policy and research work.

On Humanitarian Coordination, Mihir works on Accountability to Affected People (AAP), revised CHS and SPHERE standards at IASC and other key alliances and has spent findings ways to successfully being engaged with national and sub-national authorities in South and for Asia.

On Transformations, Mihir works with IASC Sub-group on Climate, COP28 UAE participation, planning for COP29, promoting Climate Charter, and a campaign on heatwave for urban small businesses and family-owned farms including L&D and CF and this work is expanding.

On Localisation, Mihir works with local communities on resilient food and nutrition production; mitigating and adapting to heatwaves in low income urban areas; and local NGOs and local authorities in Asia region.

Most recently Mihir has done work on resilience, humanitarian, climate inter-connections in terms: its concept, connections, contexts, and contributing to the Global Charter utilisation that he plans to take ahead in coming years.

Mihir aims to jointly transform ICVA into even more effective humanitarian action where the number and impact of humanitarian crises decrease and so do conditions that lead to such crises.

Mihir supports locally led transformation of humanitarian action that changes the fundamental condition of the crisis and power to response in favour of the affected and at risk populations, more directly, women, refuges, displaced communities, minorities, and tribals. Mihir aims to work with ICVA members to make humanitarian action an opportunity to build resilience worldwide.

Mihir aims to prominently engage local and global actions by ICVA members with each other towards synergy for effective humanitarian action.

Mihir is familiar with and has skills for ICVA's all six ways of working including research and data analysis, convene diverse group of stakeholders, connect excluded and marginal groups to mainstream, advocate for the missing and missed voices of the poor women, minorities, migrant labour, and tribals, support organisations of affected population, and collaborate with all stakeholders at local, national, and global levels.

# Amity Foundation, China Ms. Ling Chunxiang

### Organisation profile

Amity Foundation is an independent Chinese NGO founded in 1985 on the initiative of Chinese Christians led by Bishop K.H. Ting and joined by people from all walks of society, works to promote education, public health, poverty alleviation, social welfare, community development, environmental protection, climate change, disaster relief and other philanthropic undertakings in China and other parts of the world. Amity projects have benefited more than ten million people at home and abroad.

Aspired to grow into an international organization with a global reach, Amity identified and placed internationalization at the core of its organizational strategy since 2009 and has continuously invested in international programs and organizational capacity to operate globally. Its global footprint include Amity Hong Kong Office established in 1986, an international office in Geneva established in 2016 (the first Chinese NGO to set up an office in Geneva), African Office in Ethiopia in 2015 and Kenya Office in 2019. Plus, Amity Foundation is member of key international humanitarian NGO networks such as ACT Alliance since 1996/2010 and ICVA in 2020 as its first member from China. Amity acquired the UN ECOSOC special consultative status in 2014, and has forged partnership or in dialogue with several UN agencies such as UNHCR and UNICEF mainly in the areas of humanitarian action and refugees work.

Amity is primarily operational with humanitarian work as one of its key program areas. Amity responded to the fire hit the forest in northeastern China back in 1987 and has responded to all the major natural disasters that hit across China ever since. Amity has been one of the few top foundations in China in Disaster Relief area. From early 2010s, Amity began to respond to disasters affected other countries, namely the cyclone hit Philippines in 2013 and later years, the earthquake hit Nepal in 2015, the earthquake that hit Ecuador in 2016, the flood hit Sri Lanka in 2017, the drought that hit Ethiopia in 2017, the flood hit Pakistan in 2022, and more recently the earthquake hit the Turkey in 2023. Now its humanitarian work has reached over twenty countries spreading from south-east and south Asia, Africa to Latin America. Amity consciously applied and localized the international standards and principles such as Sphere and CHS in those humanitarian responses.

In recent years, Amity also steps up its efforts on humanitarian advocacy. In 2014, Amity initiated and cooperated with several other organizations hosting the Asia Disaster Relief Conference in China. In 2016, Amity and other organizations initiated the Disaster Relief Committee within the China Charity Alliance and acted as the chairing member till now. Amity is also a key member of China NGO Centre for Disaster Risk Reduction (CNCDRR). In 2018, Amity led to set up the Benevolence Group and was granted Sphere's Focal Point, the first and the only one so far from mainland China. The Benevolence Group contributed to the global consultation of SPHERE handbook revision and jointly launched the localized Chinese version of Sphere handbook with Oxfam HK in Beijing in December 2019. Amity has trained Chinese humanitarian actors and policy makers on Sphere and accountability, localized key policy documents such as the UN and ISAC Collective Outcomes Light Guidance, ICVA's brief on the Grand Bargain, to advance Chinese humanitarian NGOs' capability in understanding and applying international standards.

Amity also attended key global and regional humanitarian conferences, notably OCHA's HNPW, RHPW (Asia Regional Humanitarian Partnership Week), Civil Society 20 Summit in the past few years to share our practice and experience from global south. With ICVA's support, Amity also organized seminars and webinars on localization to amplify the voices from China's civil society.

She joined the organization in 1999 and has been working with Amity for twenty-five years, successively taking the roles of Deputy General Secretary, Assistant General Secretary, Director of Administration and Management team and Rural Development Project Manager prior to be appointed as General Secretary in September 2018. Under her leadership, Amity has become one of the leading foundations in China with an annual income of over 60 million USD in 2023 with more than 430 staff members for different philanthropic work. It's also widely recognized as one of the top humanitarian NGOs in China, responding to disasters both in China and beyond.

She's the key decision-maker in Amity's contact with ICVA and membership application. In October 2019, she attended a conference that was jointly organized by Amity and ICVA where she met with ICVA leadership which paved the way for Amity's membership to ICVA. She's also a strong supporter to ICVA-Amity strategic partnership, under which we localized ICVA's Grand Bargain brief and UN-ISAC light guidance document to Chinese audience and jointly organized a webinar in May 2022 to introduce the humanitarian coordination mechanism at global, regional and country levels to Chinese audience.

In May 2021, Ling was successfully elected into ICVA board. In her past 3-year tenure, she actively attended the board meetings, bringing in a good knowledge about Chinese NGO sector and rich experiences in humanitarian responses. She also serves in the Membership Committee. ICVA is much better connected with Chinese humanitarian sector and enrolled more members from China. The fact that she's a senior female leader of a leading NGO from China in the global south will bring more diversity to ICVA's new board.

# Asylum Access, USA Ms. Deepa Nambiar

#### Organisation Profile

Asylum Access supports forcibly displaced individuals and communities as they reclaim their rights, agency and power. We aim to create a world where refugees everywhere can live safely, move freely, work, attend school and rebuild their lives. We advocate for a response to forced displacement that honors refugees' freedom, dignity and autonomy, while also strengthening the communities that welcome them.


Asylum Access promotes refugees' rights in two main ways:

- Our three national NGOs in Thailand, Malaysia, and Mexico hold their governments accountable
  through the strategic combination of legal empowerment and inclusive policy advocacy. Asylum
  Access organisations are registered independently in their respective countries, and staffed and led
  by members of host and refugee communities.
- At the global level, our Global Systems Change and Partnerships teams work to transform the overall system of refugee protection to prioritize access to human rights and shift power to local communities through equitable partnerships and advocacy to localize protection. We do this through effective and inclusive advocacy with locally embedded CSO partners targeting institutions of power, while strengthening the capacity of local CSOs. These efforts require the full participation and leadership of communities most affected: refugees themselves and their host communities.

Asylum Access is both an international refugee-led NGO (registered as a global organization in the United States), and a family of national organizations run by host and refugee community leaders in Malaysia, Mexico, and Thailand in collaboration with communities. Asylum Access also houses the Resourcing Refugee Leadership Initiative (RRLI) (a refugee-led grantmaking and advocacy organization supporting refugee-led organizations around the world) and sits on its Coalition as a member of the governance body.

She was also the Asia Regional Coordinator for the International Detention Coalition, and previously worked with UNHCR. She is currently the Co-Chair of the Pledge for Change Equitable

In her current role as Director of Partnerships of Asylum Access, she engages with institutions, local partners and INGO partners to shift power, resources and opportunities to those who are most proximate to the experience of forced displacement through equitable partnerships and localized protection. Being in the senior leadership of an organization that has multiple identities (refugee-led INGO, family of national human rights organizations and convenor of a global refugee-led coalition (RRLI), and having previously founded and led Asylum Access Malaysia, she can bring a unique vantage point to the Board of multiple perspectives of critical actors within the humanitarian and forced displacement sector.

## Bondeko Refugee Livelihoods Center, Uganda Mr. Paul Bahati Bebin Kithima

#### Organisation Profile

Bondeko Refugee Livelihoods Center was established in 1997 by a group of refugees under the leadership of Reverend Father Michel Lingisi, a Congolese refugee, in response to crises in the African Great Lakes region. Bondeko Center supports impoverished, often traumatized refugees, especially women and children, who reach Kampala the capital city of Uganda without connections or aid. In 2023 more than 1000 refugees participated in our programs. The organisation is officially registered and is headquartered in the capital city of Kampala, in Uganda. It is a well-structured organisation comprising a Management Team and a Board of Directors.

**Vision**: We envision a future where the skills and capabilities of refugees to support and assist each other are recognized, and human rights, community acceptance, and economic independence are promoted for forcibly displaced people.

Mission: "We want refugees to be self-reliant and enjoy human rights in the communities where they live".

## **Video presentation**



My name is Paul Kithima, and I am the CEO of Bondeko Refugee Livelihoods Center in Kampala, Uganda. My work at Bondeko is entirely focused on humanitarian action, as Bondeko's remit in Uganda is to support and empower refugees and asylum seekers to become self-reliant and enjoy human rights where they live. Uganda is host to 1.6 million refugees who have fled mainly from neighbouring African countries. Hundreds of refugees each year find their way to Bondeko, seeking to participate in the skills training and educational programs that Bondeko offers, as well as for emergency support. I lead all aspects of Bondeko's humanitarian response, from strategy through implementation. As the CEO, I oversee all people management, program identification and implementation, operations, budget and finances, and proposal writing. I represent Bondeko with the local authorities but also at international conferences and with partner organizations and other external stakeholders. I'm accountable to Bondeko's Board of Directors.

In 2012, I survived persecution and torture in the Democratic Republic of Congo due to my political opinions (as a youth politician at that time) and fled to Uganda for asylum.

A year later, after my recovery, I started working as an outreach volunteer with national and international organizations providing emergency relief and outreach programs for refugees, asylum seekers and survivors of torture and sexual violence in both Kampala and refugee camps.

From 2013 to 2018, I participated in numerous field missions, such as supporting those trying to find missing relatives, distributing clothing through Relief programs, implementing protocols for documentation and investigation of sexual violence, identifying and verifying refugees and asylum seekers, etc.

In 2018, I was chosen by community members to lead Bondeko (an RLO founded in 1997) as my predecessor was about to move to Canada for resettlement.

For the past five years, in addition to being the CEO of Bondeko, I have been responsible for the strategic leadership and operational management of several other organizations, including as Chairperson of Bright Future initiative for the Protection of Children with Disabilities and the CEO of GLOs, The Grassroots Consortium.

I also champion the Localization of humanitarian responses at a global level. In 2022, I was a panelist in the main session on Localization during the UNHCR Global Consultations with NGOs in Geneva and a Speaker during the HC Dialogue on Protection Challenges in December. I was also a panelist in the session on Localization during the 11<sup>th</sup> African Union Symposium in Nairobi in November 2023 and a panelist during the linked event organized by the World Bank in Geneva during the Global Refugee Forum in Geneva in December 2023. Additionally, I participated in the Reference Group, which developed a Joint Multi-Stakeholder Pledge on Advancing Localization in Displacement and Statelessness responses announced at the GRF in December 2023.

I have a Bachelor's Degree in Political Science from UNIGOM in the DRC, but it is through my lived experience in a protracted refugee situation and my expertise from the field as a community leader that I have deeper insights in areas such as forced migration, humanitarian aid, advocacy and coordination which can help ICVA make informed decisions and better serve its members and the broader humanitarian community.

As a Board member, I will contribute to ICVA's mission and vision by actively participating in regular board meetings, reviewing and approving strategic plans and providing guidance on the ICVA 2030 strategy.

I will assist in fundraising efforts and make sure ICVA has the necessary resources to carry out its activities effectively.

I will also support mechanisms put in place for monitoring and evaluating ICVA's programs and initiatives to ensure they are achieving their intended impact, and I will always provide feedback on areas for improvement.

Further, I will always raise my voice to champion principled humanitarian action and advocate for addressing the impact of climate change on humanitarian efforts.

I will also advocate for inclusive and community-led approaches to humanitarian action and promote ICVA's efforts to engage in agile collaborative partnerships.

Lastly, I will always make sure my contribution aligns with ICVA's goal of being globally distributed and locally rooted.

We were one of the first organisations to be certified by the Humanitarian Accountability Partnership and, in line with the Core Humanitarian Standard.

It has been a privilege to serve the ICVA network within ICVA's Board these past six years, helping to set a reinvigorated direction through the 2030 Strategy and lead the strategy through the first three of its nine years, completing a process of change, consolidation and focus. As the 2030 Strategy sets out, ICVA members will need to continue to operate within restrictive spaces: tackling impediments to humanitarian access; issues of over-assertive sovereignty and shrinking civic space; the politicization of aid; the lack of impunity; and the impacts of climate change.

However, three years into the 2030 Strategy, in Palestine, Syria, Ukraine and South Sudan, and elsewhere, we are yet again witnessing an escalation in extreme impunity, further politicisation and disrespect for international law, and attacks which question our basic humanity.

Alongside this, the humanitarian community has not made adequate progress on commitments to address systemic gaps in humanitarian financing, resilience, climate resilience, and anticipatory action.

Working with the rest of ICVA's Board, we would serve the interests of all ICVA members to:

increase ICVA's global reach and influence to help collectively and robustly tackle the fundamental challenge to humanity and humanitarian principles which we all face; reinvigorate our joint efforts for joint, ambitious and proactive responses to address vital practical issues during responses, including continued global action to tackle impunity and uphold international law, hunger, and pursue mechanisms and funding for climate resilience, anticipatory and early action; promote the critical role and value of an eco-system of diverse NGOs in humanitarian action rather than a trend of resources favouring large agencies;

the leadership of humanitarian response by national and local NGOs, including principled faith-based actors, and the agency of affected populations in the driving seat of response; the value of cash-based responses, and approaches that take advantage of an appropriate nexus of humanitarian and development aid.

We would do this by:

Continuing to pursue proactive and robust collective action in response to attacks on civilians, and our common humanity;

Continuing to promote and pursue robust good governance and ICVA's values; Reinvigorating our Board's vision and action plan for diversity, equity and inclusion; A renewed focus on our collective 2030 Strategy as we approach the half way point; Supporting stability as we come out of a transition for the secretariat.

**Shelter and Reconstruction** IBC provides reconstruction of social infrastructure units, including temporary and permanent shelter, education, and health services after the state of emergency in disaster-affected regions. In this process, it also carries out activities to improve the livelihoods and socio-economic lives of the victims.

**Civil Society and Social Development** IBC contributes to and supports civil society organizations, local organizations, and social groups in the field of civil society and social development to develop their financial and technical capacities, increase the effectiveness of their existing activities, create new activities, and achieve sustainable growth by organizing and networking.

**Training** IBC supports school and out-of-school education. In addition to increasing the capacity of educational units by providing them with the necessary equipment, it also supports programs such as vocational, cultural, and skills development programs carried out by official educational institutions.

**Health** In addition to increasing the existing capacity in the field of health, such as meeting and renewing the need for equipment and supplies, activities are also carried out to raise the awareness of the

community to utilize health units, take preventive measures against diseases, prevent infectious diseases and improve personal hygiene.

**Social Cohesion** IBC promotes the culture of coexistence with the support of academic staff, local government institutions, and stakeholders, especially to strengthen communication between refugees and host communities and contribute to peace-based social dialogue. # Medair, Switzerland Ms. Anne Reitsema

#### Organisation Profile

Medair, founded in 1989, is an international humanitarian organisation focusing on emergency response, with extensive experience and expertise in health, nutrition, water, sanitation and hygiene (WASH), emergency shelter and infrastructure. Currently, Medair runs humanitarian operations in 14 countries around the world, including Afghanistan, Ukraine, Democratic Republic of Congo, South Sudan, Sudan, Somalia, Kenya, Chad, Madagascar, Yemen, Turkey, Jordan, Syria and Lebanon. The Global Emergency Response Team of Medair focuses on rapid onset emergencies and is ready to be deployed for disasters or humanitarian crisis swiftly.

In 2020, alongside the ongoing country programmes' emergency response and recovery work, Medair restarted operations in Sudan (left in 2011) during the COVID-19 pandemic, including initiating a response to the Tigrayan refugee crisis in east, as well as responding to the Beirut blast in Lebanon and Hurricanes Eta and Iota in Honduras. In 2021, Medair responded to the conflict in Tigray in northern Ethiopia, and responded in Amhara as the conflict spread in 2022. At the start of that year, Medair also launched a large scale response in Poland and Ukraine due to the conflict and continuously expanded and moved the response eastward towards the frontline. In 2023, Medair responded to the earthquake in Turkey and Syria, scaled up responses to the Sudan crisis in Sudan/South Sudan and initiated as response in Chad, as well as scaling up in DR Congo.

Aside from the emergency response capacity and frequent emergency responses in Medair's longer term country programmes, for example South Sudan, DR Congo, Somalia, Afghanistan and Madagascar, Medair's other notable emergency responses in previous years include the earthquake in Haiti (2010), Typhoon Haiyan in Philippines (2013), Yazidi displacement in Iraq (2014), Ebola outbreak in Sierra Leone (2014), earthquake in Nepal (2015), Rohingya displacement in Bangladesh (2017), Ebola outbreak in DR Congo (2018), Typhoon Mangkut in Philippines (2018), earthquake and tsunami in Indonesia (2018) and Cyclone Idai and Kenneth in Mozambique (2019). Note: Medair has been continuously responding to the Syrian refugee crisis in Lebanon, Jordan and Syria since 2014.

Medair participates in ICVA and provides feedback through various platforms. Medair engages in different coordination mechanisms at both global and country levels.

At global level, Medair is involved in the global health cluster and is currently the co-chair of the Strategic Advisory Group (SAG) and is in the reproductive health and quality working groups; participates in the Global MAMI Network and the Global Cholera Task Force; and is part of IASC WHO MHPSS RG. Globally Medair advocated for equitable vaccine access for populations in humanitarian crisis with the Global Health Cluster and NetHope. Medair is also involved in the global WASH cluster and is a workstream co-lead of the global hygiene promotion in emergencies working group and co-lead of the WASH Road Map initiative 6. We have representatives in the ICVA Access Working Group and the Principled Humanitarian Action Steering Committee. Medair's Security Advisor currently chairs the Global Interagency Security Forum (GISF) steering group.

At country level, Medair has been engaging in various coordination bodies such as HCTs and SAGs of different clusters. In Yemen, Medair is on the INGO Forum steering committee and INGO rep to the HCT. In Sudan, Medair is on the INGOF Steering Committee. In Syria, the Medair country director is on the DINGO Steerco and the HCT and is a member of the SIRF Board. In Jordan, Medair is an active member in the Jordan INGO Forum (JIF) and Health, C4H, Protection, and MHPSS Working Groups along with being cochairs of the Referral Coordination and Interagency Coordination Working Groups. In Lebanon, Medair's Country Director is a steering committee member of the Lebanon Humanitarian INGO Forum (LHIF) and is actively participating and contributing to the Lebanon Crisis Response Plan (LCRP) coordination mechanism, including, but not limited to, Basic Assistance, Shelter, Health, Nutrition, MHPSS, WASH, Logistics, and other sectors and working groups. In South Sudan, Medair takes part in the Health SAG, SRH and MHPSS TWGs, Nutrition SAG and Scaling Up Nutrition in SS TWG; WASH SAG, Sanitation and Accountability and

Quality Assurance (AQA) TWGs. Medair is also on the South Sudan RRM group and Needs Analysis Working Group. In Afghanistan, Medair is on the Nutrition SAG and is a member of the IMAM, Assessment Information Management, MIYCN and capacity development technical working groups of the nutrition cluster.

NPA adopts a principled approach to humanitarian action, while recognising that many of our partners have played a political role in their society prior to a crisis. NPA holds that the principles of humanity and impartiality are fundamental, ethical obligations which define the objective of humanitarian action; while the principles of neutrality and independence have to be negotiated and contextualized in every response we are involved. No humanitarian organization or institution is entirely neutral and independent.

#### If yes, what qualities would you bring to the position of Chair?

A genuine commitment to principled and effective humanitarian action. Ability to articulate a compelling vision, mobilise diverse actors, and nurture a collective approach. Ability to listen and facilitate an informed conversation, often by bringing diverse, different or polarised opinions together and by appreciating dissenting voices. While working as the chair of inter-agency initiatives (e.g. Sphere board), I also learned not to take more than 10-15% of the airtime during board meetings, to make sure that the Executive Director/ CEO and staff are given time and fellow board members are encouraged to listen, reflect and form ideas and consensus around complex issues.

Availability and time commitment not just during board meetings, but also to do the preparatory work before and after board meetings. My employer, Plan International, recognizes the responsibility that comes with the board chair position and is ready to make provisions to prioritise ICVA's work as and when needed. Be accountable and take the board matters seriously and prioritise.

Encourage all board members for input and foster collaboration between humanitarian actors and civil society across continents. Ability to mobilise all board members and thus optimise the full human capital of the board in its entirety. Facilitate a culture where board members are (and not just the chair) taking responsibility to represent ICVA in forums. Able to strengthen trust and collaboration, manage risks and generate specific, actionable, clearly formulated resolutions—and confirm every board member understands and supports such resolutions.

Good understanding of what I don't know and openness to seek support from subject matters experts.

# Refugees Seeking Equal Access at the Table (R-SEAT), Canada Ms. Rez Gardi

Refugees Seeking Equal Access at the Table (R-SEAT) is an international advocacy initiative working to enhance the effectiveness of global refugee responses, by co-designing mechanisms to amplify refugee leadership ecosystems and increase the participation of refugees at state levels in a meaningful, sustainable, and transformative way. R-SEAT is a non-profit organization led by refugees, working to empower refugees and to build participatory mechanisms for refugees around the world. As Co-Managing Director ofR-SEAT, we have successfully scaled our work across over 10 countries of varying positionalities to the global system, and have furthered the emerging norm of meaningful refugee participation internationally. We are specifically interested in exploring how ICVA members may further benefit from these types of connections. Utilizing each of these skills allows for a balanced approach which centres neutral data in deciding on new agenda items, which is another skill I would bring to the ICVA Board under my tenure.
